

Renew Active™ Terms and Conditions

Eligibility Requirements

- Only members enrolled in a participating Medicare Advantage Insurance Plan insured by UnitedHealthcare® Insurance Company (“UnitedHealthcare®”) are eligible for a no additional cost individual membership at participating locations as part of the Renew Active™ program (“Program”).

Enrollment Requirements

- Membership and participation in the Program is voluntary.
- You must enroll in the Program according to the instructions provided on this website. More specifically, you must obtain the confirmation ID and bring it to a participating location to receive a membership at no additional cost.
- Program enrollment is on an individual basis and the Program's waived monthly membership rate for standard membership services at participating locations is only applicable to individual memberships.
- You are responsible for any and all non-covered services and/or similar fee-based products and services offered by participating locations that require a separate fee to be paid to participating locations. Including, without limitation, fees associated with personal training sessions, specialized classes, or additional/enhanced facility membership levels beyond the basic or standard membership level.

Data Requirements

- Optum (the Program administrator) and/or your fitness center will collect and electronically send and/or receive the minimum amount of your personal information required in order to facilitate the Program in accordance with the requirements of applicable laws, including privacy laws. Such required personal information includes, but is not limited to, program confirmation ID, fitness center membership ID, activity year, and monthly visit count. By enrolling in the Program and receiving the pre-determined monthly membership rates from your participating location, you accept

the Terms and Conditions of the Program set forth herein and authorize Optum to request, and your fitness center to provide, such personal information.
